
# financial report

We are happy to report another financially rewarding year.

Income for the year net of fundraising costs was \$228,000. Several significant donations were received, including \$43, 000 from the Ryde Club of Rotary specifically for Afghanistan and a total \$30,000 for the Congo project. The emphasis on fundraising continued and a greater number of successful events were held, not least being the first indigo foundation Canberra dinner, which attracted 150 people. Interest from bank deposits increased due to better cash flow management.

As in prior years the Management Committee continued to increase the level of project support. After careful evaluation of all projects an additional \$22,000 was allocated. This sum includes the cost of the development coordinator, whose consistent support and experience is vital to the quality of our projects. Expenditure was as follows:

The costs include monitoring and evaluation visits by project managers and the development co-ordinator to all the projects with the exception of Australia.

Administration costs were tightly controlled. The recruitment of a general manager in the third quarter slightly increased costs.

However, this was partially offset by funds raised directly as a result of her employment.

The financial administrator, Lyndall Grose improved our financial systems and enhanced reporting. Lyndall has developed a quarterly report for Project Managers, enabling them to keep track of the income and expenditure of their own projects more efficiently. She is currently employed for four hours a week.

### Highlights: 2010-2011

- Project support increased by 13%.
- Strong, stable income. Inaugural Canberra dinner raised \$10,000.
- Increase in net assets by 20%.
- Employment of general manager.
- Administration costs low 11% of income.

Net assets increased by \$16,000 compared to 2009-10. We have sufficient funds to support all existing projects for the first six months of 2011-2012. Naturally, continuing support from our generous donors will be required for the longer term!

Financially, this was a successful year and we are well placed to build on that success in the future.
